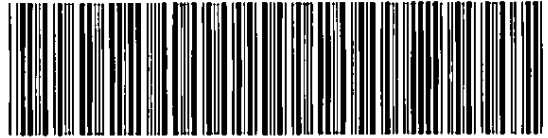



3. Business Purpose

The purpose for which the corporation is formed is any purpose for which corporations may be organized under the Not-for-Profit Corporation Law as a charitable corporation.

11. Additional Entity – Specific Information
