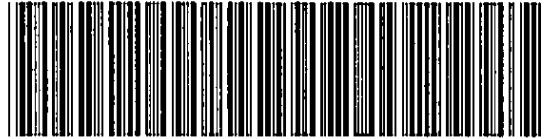

Fifth: Adoption of revocation of dissolution

Rising Starz Developmental Organization INC was fraudulently dissolved by a former board of director member. Former member, Myrtissa Sumler, was expelled by the Rising Starz Developmental Organization INC board of directors on May 6th, 2022 due to inappropriate behavior, unwilling to fulfill her role on the board of directors and to the team. On May 6, 2022, a new filing agent and president was updated and accepted on Sunbiz. Myrtissa Sumler was removed as President and Marquita Phillips was removed as Registered agent. Ms. Phillips was also removed from the board of directors voluntarily and the board accepted her resignation. These meetings are all documented.

On May 26, 2022, Myrtissa Sumler was allowed to file a voluntary dissolution of the organization without any current board member knowledge nor proof of the board of directors being in agreement. In addition, Myrtissa was not documented on file as a member of the organization on that date she filed the paperwork. She fraudulently dissolved The Rising Starz Developmental Organization INC. without permission of the board of directors.
