

# ARTICLES OF INCORPORATION OF

# CHARLOTTE HARBOR COMMERCIAL CONDOMINIUM ASSOCIATION, INC.

(A NON-PROFIT FLORIDA CORPORATION)

# ARTICLE I.

The name of this corporation is CHARLOTTE HARBOR COMMERCIAL CONDOMINIUM ASSOCIATION, INC. The initial principal office of the corporation is 4137 James Street, Port Charlotte, Florida 33980, and the mailing address of the corporation is 4137 James Street, Port Charlotte, Florida 33980.

#### ARTICLE II.

The purpose for which this corporation is organized is to act as the governing association of the CHARLOTTE HARBOR COMMERCIAL CONDOMINIUM, a non-residential Condominium, located in Charlotte County, Florida, and to operate property owned by the Association.
