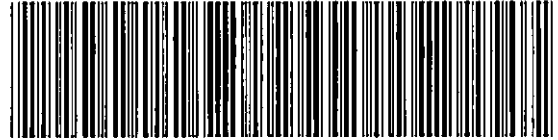



On March 23rd 2023, Pinellas County Harm Reduction Initiative, Inc accidentally filed articles of dissolution instead of amending the corporate documents and adding a dissolution clause with Florida Department of State Division of Corporations as there were none before. The meeting on December 10, 2022 in which the article reference was the meeting date that the dissolution clause was adopted by Pinellas County Harm Reduction Initiative, Inc.
