The undersigned hereby adopts the following articles of incorporation in Compliance v Chapter 617, F.S., (Not for Profit).

#### **Article 1 Name**

The name of this corporation shall be Havendale Community Development, Inc.

Notwithstanding any other provision of these articles, the corporation shall not carry c any other activities not permitted to be carried on: (a) by a corporation exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1986 or tl corresponding provision of any future United States Internal Revenue law or: (b) by a corporation, contributions to which are deductible under Section 170(c) of the Interna Revenue Code of 1986 or the corresponding provisions of any future United States Inte Revenue laws.


# **Article 11 Bylaws**
