Notwithstanding any other provision of this document, the corporation shall not carry on any other activities not permitted to be carried on (a) by any organization exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code. SOCIAL WORKS OF THE ORDER OF CHRISTIAN SPIRITUALISTS VALE DO AMANHECER NELANO INC is not organized and shall not be operated for the private gain of any person. The property of the corporation is irrevocably dedicated to its educational and charitable purposes. No part of the assets, receipts, or net earnings of the corporation shall inure to the benefit of, or be distributed to any individual. The corporation may, however, pay reasonable compensation for services rendered, and make other payments and distributions consistent with these Articles.

Upon termination or dissolution of the SOCIAL WORKS OF THE ORDER OF CHRISTIAN SPIRITUALISTS VALE DO AMANHECER NELANO INC, any assets lawfully available for distribution shall be distributed to one (1) or more qualifying organizations described in Section 501(c)(3) of the Internal Revenue Code of 1986 (or described in any corresponding provision of any successor statute) which organization or organizations have a charitable purpose which, at least generally, includes a purpose similar to the terminating or dissolving corporation. The organization to receive the assets hereunder shall be selected by the discretion of a majority of the managing body of SOCIAL WORKS OF THE ORDER OF CHRISTIAN SPIRITUALISTS VALE DO AMANHECER NELANO INC.
