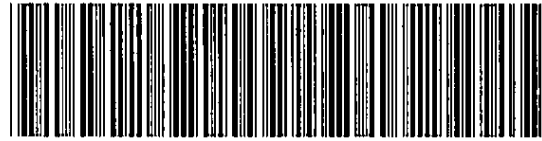



provisions of the General Laws of the State of Florida and Section 501(c)(3) of the Code.

Upon dissolution of the Corporation, any assets remaining after the satisfaction of all
corporate liabilities shall be conveyed to such organization or organizations as shall be selected

by the affirmative vote of a majority of the Directors, provided, however, that such organization or organizations
must be recognized as exempt from federal income taxation under Sections 501(c)(3) and 170(c)(2)

of the Internal Revenue Code of 1986, as amended, or corresponding sections of any prior or future law,
or to the federal, state, or a local government to be used for exclusively public purposes.


