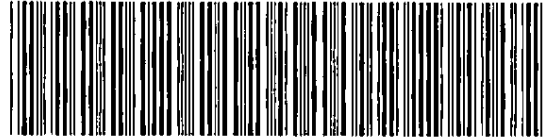



**ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF  
ESPLANADE AT WESTVIEW HOMEOWNERS ASSOCIATION, INC.**

Pursuant to the provisions of Section 617.1006, Florida Statutes, ESPLANADE AT WESTVIEW HOMEOWNERS ASSOCIATION, INC., a Florida not for profit corporation, adopts the following amendment to its Articles of Incorporation (the "**Articles**"):

1. Article I of the Articles is amended in its entirety to read as follows:

"Article I **NAME AND LOCATION**

The name of this corporation shall be **EA WESTVIEW HOMEOWNERS ASSOCIATION, INC.** (hereinafter referred to as the "**Association**"), and its initial office for the transaction of its affairs shall be 2600 Lake Lucien Drive, Suite 350, Maitland, FL 32751."

2. Turnover as described or defined in the Articles has not occurred, no Member of the Association is entitled to vote on these articles of amendment, and these articles of amendment were adopted by the Board of Directors of the Association pursuant to Article X Section (a) of the Articles, at a meeting duly called and noticed in accordance with the Association's Bylaws and held on August 14, 2024.
