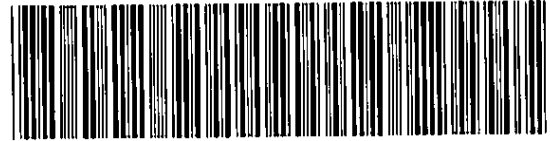

ARTICLES OF INCORPORATION

OF

A Florida not for Profit Corporation

ARTICLE I - Name

The name of this corporation is, **ROBERT C. SAFFOLD, SR. MEMORIAL FOUNDATION, INC.**, a Florida not for Profit Corporation.

ARTICLE II - Duration

The existence of the corporation shall begin on November 12, 2021. This corporation shall have perpetual existence.

ARTICLE III - Principal Office

The address of the principal office is 223 Springtime Drive, Sebring, Florida 33870 and a mailing address of 223 Springtime Drive, Sebring, Florida 33870

ARTICLE IV - Purpose

The purpose for which this corporation is organized is for charitable community outreach, within the meaning of Section 501(C)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income tax under Section (501)(C)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

ARTICLE V - Membership

The qualifications for members and the manner of their admission shall be

regulated by the Bylaws.

ARTICLE VI - Initial Registered Office and Agent

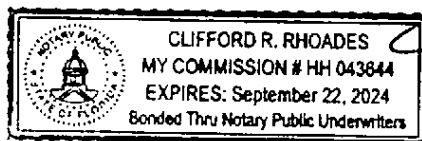
