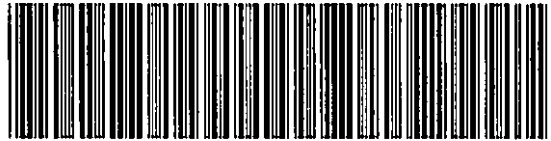



## ARTICLE IX

### *Dissolution*

No part of the net earnings of the corporation shall ever inure to the benefit of any donor, member, director or officer of the corporation or any private individual and no donor, member, director, officer of the corporation, or any private individual shall be entitled to share in the distribution of any of the corporation assets. Upon dissolution, any assets of the corporation must be distributed by the trustees, to one or more organizations recognized by the Internal Revenue Service as one organized exclusively for religious, charitable, scientific, literary or educational purposes.
