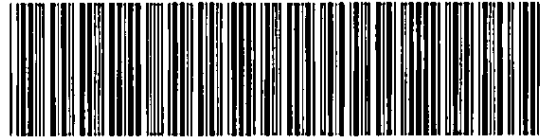

ARTICLES OF INCORPORATION OF EYE SEE COLOR PROJECT, INC.

The undersigned, for the purpose of forming a nonprofit corporation under the Florida Not-For-Profit Corporation Act, Florida Statutes Chapter 617, makes and adopts the following articles of incorporation:

Article I

The specific purpose for which the corporation is organized:
Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, but not limited to raising awareness, screening, and procuring eye glasses for children suffering from color vision deficiency, and including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article VIII

Limitations:

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in further of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article IX

Dissolution:

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

Article X

Effective date:

The effective date of the corporation shall be the date of the filing of these articles of incorporation.



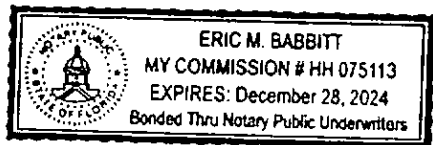


I am in receipt of your letter dated October 15, 2021 regarding the name conflict for EYE SEE COLOR PROJECT, INC. A copy of your letter is enclosed hereto for reference. I would like to request that the Articles of Incorporation for EYE SEE COLOR PROJECT, INC. be filed as is for the following reasons:

On July 20, 2021, I filed Articles of Organization for EYE SEE COLOR PROJECT LLC (L21000329450). I was the sole member and manager of the entity. My intent was to create a nonprofit entity, and I realized that I had incorrectly created a LLC instead of a nonprofit corporation. On September 18, 2021, I filed Articles of Dissolution for EYE SEE COLOR PROJECT, LLC and stated in the filing that the reason for dissolution was a name conflict with a potential nonprofit corporation.

I subsequently submitted Articles of Incorporation for EYE SEE COLOR PROJECT, INC., a nonprofit corporation. I am the President and a Director of EYE SEE COLOR PROJECT, INC., and intend to operate the nonprofit business under this name. I have no intention of ever reinstating the previous entity, EYE SEE COLOR PROJECT, LLC.

I would therefore like to request that I be permitted to use the name EYE SEE COLOR PROJECT, INC., and the enclosed Articles of Incorporation be filed. If you would like any additional information, please contact Eric Babbitt at 954-771-5299.
