# ARTICLES OF INCORPORATION SAN PABLO PROPERTY OWNERS ASSOCIATION INC. (a corporation not-for-profit)

#### I. NAME AND DEFINITIONS.

The name of this corporation shall be San Pablo Property Owners Association Inc. (the "Master Association"). All defined terms contained in these Articles shall have the same meanings as such terms are defined by the Master Declaration of Easements, Covenants and Restrictions to be recorded in the current public records of Duval County, Florida (the "Declaration").

### II. PRINCIPAL OFFICE AND MAILING ADDRESS.

The location of the corporation's principal office and its mailing address shall 177 4th Avenue North, Suite 200, Jacksonville Beach, Florida 32250, or at such other place as may be established by resolution of the Master Association's Board of Directors from time to time.

#### III. PURPOSES.

The general nature, objects and purposes of the Master Association are:

- A. To promote matters of common interest and concern of the Owners of property within the real property subject to the terms and provision of the Declaration.
- B. To own, maintain, repair and replace the Common Improvements, including without limitation the streets, street lights, landscaping, structures, and other improvements located thereon, for which the obligation to maintain and repair has been delegated to and accepted by the Master Association.
- C. To operate, maintain and manage the Surface Water or Stormwater Management System in a manner consistent with Permit Numbers 130612-6 and 130612-7, as amended, all as issued by the St. Johns River Water Management District ("SJRWMD") (ii) Permit Number SAJ-2012-01575 form the United States Army Corps of Engineers (the "ACOE"), as amended, and applicable SJRWMD rules, and to assist in the enforcement of the restrictions and covenants contained therein and in any future permits obtained from the SJRWMD and the ACOE.
- D. To cooperate with other associations responsible for administration of adjacent or contiguous properties in matters of common interest to the Master Association and such other associations and to contribute to such common maintenance interests whether within or without the Property.
- E. To provide, purchase, acquire, replace, improve, maintain, operate and repair such buildings, structures, landscaping, paving and equipment, and to provide such other services for the benefit of the members of the Master Association, as the Board of Directors in its discretion determines necessary, appropriate, and/or convenient.

- F. To operate without profit for the sole and exclusive benefit of its Members.
- G. To perform all of the functions contemplated for the Master Association and undertaken by the Board of Directors pursuant to the terms and conditions of the Declaration.

#### IV. GENERAL POWERS.

The general powers that the Master Association shall have are as follows:

- A. To hold funds solely and exclusively for the benefit of the Members for purposes set forth in these Articles of Incorporation.
- B. To promulgate and enforce rules, regulations, bylaws, covenants, restrictions and agreements to effectuate the purposes for which the Master Association is organized.
- C. To delegate power or powers where such is deemed in the interest of the Master Association.
- D. To purchase, lease, hold, sell, mortgage or otherwise acquire or dispose of real or personal property, to enter into, make, perform or carry out contracts of every kind with any person, firm, corporation or association; to do any and all acts necessary or expedient for carrying on any and all of the activities and pursuing any and all of the objects and purposes set forth in the Declaration and these Articles of Incorporation and not forbidden by the laws of the State of Florida.
- E. To fix assessments to be levied against all or any portion of the Property to defray expenses and costs of effectuating the objects and purposes of the Master Association and to create reasonable reserves for such expenditures, and to authorize its Board of Directors to enter into agreements with other property owners' associations or maintenance entities for the collection of such assessments. The foregoing shall include the power to levy and collect adequate assessments against the Members for the costs of maintenance and operation of the Surface Water or Stormwater Management System. Such assessments shall be used for the maintenance and repair of the Surface Water or Stormwater Management System, including but not limited to, work within retention areas, drainage structures and drainage easements.
- F. To charge recipients for services rendered by the Master Association and the users of the Master Association property where such is deemed appropriate by the Board of Directors of the Master Association and permitted by the Declaration.
- G. To pay taxes and other charges, if any, on or against property owned, accepted, or maintained by the Master Association.
- H. To borrow money and, from time to time, to make, accept, endorse, execute and issue debentures, promissory notes or other obligations of the Master Association for monies borrowed, or in payment for property acquired, or for any of the other purposes of the Master Association, and to secure the payment of such obligations by mortgage, pledge, or other instrument of trust, or by lien upon, assignment of or agreement in regard to all or any part of the property rights or privileges of the Master Association wherever situated.

1. To merge with any other association which may perform similar functions located within the same general vicinity of the Property.

J. In general, to have all powers conferred upon a corporation by the laws of the State of Florida, except as prohibited herein and by the terms and conditions set forth in the Declaration.

#### V. MEMBERS.

The members ("Members") shall consist of the Developer and each Owner of a Parcel within the Property.

#### VI. VOTING AND ASSESSMENTS.

- A. Subject to the restrictions and limitations hereinafter set forth, each Member shall be entitled to the number of votes in the Master Association computed as follows:
- 1. The Owner or Owners (as the case may be) of the Multifamily Parcel shall have ten (10) votes. The Owners of the Multifamily Parcel may allocate such votes among themselves.
- 2. The Owner or Owners (as the case may be) of the Mixed Use Parcel shall have twenty (20) votes. The Owners of the Mixed Use Parcel may allocate such votes among themselves.
- 3. The Owner or Owners (as the case may be) of the Commercial Parcel shall have five (5) votes. The Owners of the Commercial Parcel may allocate such votes among themselves.
- B. When a Member is comprised of one or more persons or entities, all such persons shall be Members, and the vote(s) for the applicable portions of the Property shall be exercised as they among themselves shall determine. The votes allocated to any Member pursuant to these Articles, cannot be divided for any issue and must be voted as a whole, except where otherwise required by law. The affirmative vote of a majority of the votes allocated to the Members cast at any meeting of the Members duly called at which a quorum is present, or cast by written ballot by a quorum of the membership, shall be binding upon the Members and the Master Association.
- C. The Master Association will obtain funds with which to operate by assessment of the Owners in accordance with the provisions of the Declaration, as supplemented by the provisions of the Articles and Bylaws of the Master Association relating thereto.

#### VII. BOARD OF DIRECTORS.

- A. The affairs of the Master Association shall be managed by a Board of Directors consisting of three (3) Directors. Directors need not be members of the Master Association and need not be residents of the State of Florida. For so long as it shall own any portion of the Property, the Developer shall have the right to appoint all of the Directors.
- B. Elections shall be by plurality vote. At the first annual election of the Board of Directors following the termination of the Developer's right to appoint all of the Directors, the terms of office of the two (2) Directors receiving the highest number of votes shall be established at two (2) years. The term of office of the remaining Director shall be established at one (1) year. Thereafter, as many Directors shall be

elected and appointed, as the case may be, as there are regular terms of office of Directors expiring at such time; and the term of each Director so elected or appointed at each annual election shall be for two (2) years expiring at the second annual election following their election, and thereafter until their successors are duly elected and qualified, or until removed from office with or without cause by the affirmative vote of a majority of the Members which elected or appointed them. In no event can a Board member appointed by the Developer be removed except by action of the Developer. Any Director appointed by the Developer shall serve at the pleasure of the Developer, and may be removed from office, and a successor Director may be appointed, at any time by the Developer.

C. The names and addresses of the members of the first Board of Directors who shall hold office until the first annual meeting of the Members and until their successors are elected or appointed and have qualified, are as follows:

#### VIII. OFFICERS.

The Officers of the Master Association shall be a President, a Vice President, a Secretary and a Treasurer, and such other officers as the Board may from time to time by resolution create. Any two (2) or more offices, may be held by the same person except the offices of President and Secretary. Officers shall be elected for one (1) year terms in accordance with the procedure set forth in the Bylaws. The names of the officers who are to manage the affairs of the Master Association until the first annual meeting of the Members and until their successors are duly elected and qualified are:

#### IX. CORPORATE EXISTENCE.

The Master Association shall have perpetual existence. These Articles shall become effective upon filing as prescribed by law.

#### X. BYLAWS.

The Board of Directors shall adopt Bylaws consistent with these Articles. Such Bylaws may be altered, amended, or repealed by resolution of the Board of Directors.

#### XI. AMENDMENTS TO ARTICLES OF INCORPORATION AND BYLAWS.

#### XIV. INDEMNIFICATION OF OFFICERS AND DIRECTORS.

- A. To the extent allowed by law, the Master Association hereby indemnifies any Director or officer made a party or threatened to be made a party to any threatened, pending or completed action, suit or proceeding:
- 1. Whether civil, criminal, administrative, or investigative (other than one by or in the right of the Master Association to procure a judgment in its favor), brought to impose a liability or penalty on such person for an act alleged to have been committed by such person in his capacity as a Director or officer of the Master Association or as a director, officer, employee or agent of any other corporation, partnership, joint venture, trust or other enterprise which he served at the request of the Master Association, against judgments, fines, amounts paid in settlement and reasonable expenses, including attorneys' fees, actually and necessarily incurred as a result of such action, suit or proceeding or any appeal thereof, if such person acted in good faith in the reasonable belief that such action was in the best interests of the Master Association, and in criminal actions or proceedings, without reasonable grounds for belief that such action was unlawful. The termination of any such action, suit or proceeding by judgment, order, settlement, conviction or plea of nolo contendere or its equivalent shall not in itself create a presumption that any such Director or officer did not act in good faith in the reasonable belief that such action was in the best interest of the Master Association or that he had reasonable grounds for belief that such action was unlawful.
- 2. By or in the right of the Master Association to procure a judgment in its favor by reason of his being or having been a Director or officer of the Master Association, or by reason of his being or having been a director, officer, employee or agent of any other corporation, partnership, joint venture, trust or other enterprise which he served at the request of the Master Association, against the reasonable expenses including attorneys' fees, actually and necessarily incurred by him in connection with the defense or settlement of such action, or in connection with an appeal therein if such person acted in good faith in the reasonable belief that such action was in the best interest of the

Master Association. Such person shall not be entitled to indemnification in relation to matters to which such person has been adjudged to have been guilty of gross negligence or misconduct in the performance of his duty to the Master Association unless, and only to the extent that, the court, administrative agency, or investigative body before which such action, suit or proceeding is held shall determine upon application that, despite the adjudication of liability but in view of all circumstances of the case, such person is fairly and reasonably entitled to indemnification for such expenses which such tribunal shall deem proper.

- B. The Board of Directors shall determine whether amounts for which a Director or officer seeking indemnification were properly incurred and whether such Director or officer acted in good faith in a manner he reasonably believed to be in the best interests of the Master Association, and whether, with respect to any criminal action or proceeding, he had no reasonable ground for belief that such action was unlawful. Such determination shall be made by the Board of Directors by a majority vote of a quorum consisting of Directors who were not parties to such action, suit or proceeding.
- C. The foregoing rights of indemnification shall not be deemed to limit in any way the powers of the Master Association to indemnify under applicable law.

#### XV. TRANSACTION IN WHICH DIRECTORS OR OFFICERS ARE INTERESTED.

- A. No contract or transaction between the Master Association and one or more of its Directors or officers, or between the Master Association and any other corporation, partnership, Master Association, or other organization in which one or more of its Directors or officers are Directors or officers, or in which they have a financial interest, shall be invalid, void or voidable solely for this reason, or solely because the Director or officer is present at or participates in the meeting of the Board or committee thereof which authorizes the contract or transaction, or solely because his or their votes are counted for such purpose. All such contracts or transactions shall, however, be fair and reasonable and upon terms reasonably comparable to those which could be obtained in arms-length transactions with unrelated entities. No Director or Officer of the Master Association shall incur liability by reason of the fact that he is or may be interested in any such contract or transaction.
- B. Interested Directors may be counted in determining the presence of a quorum at a meeting of the Board of Directors or of a committee which authorized the contract or transaction.

#### XVL DISSOLUTION OF THE MASTER ASSOCIATION.

- A. Upon dissolution of the Master Association, all of its assets remaining after provisions for creditors and payment of all costs and expenses of such dissolution shall be distributed in the following manner:
- 1. Dedication to any applicable municipal or other governmental authority of any property determined by the Board of Directors of the Master Association to be appropriate for such dedication and which the authority is willing to accept.
- Remaining assets shall be distributed among the Members, subject to the limitation set forth below, each Member's share of the assets to be determined by multiplying such remaining assets by a fraction the numerator of which is all amounts assessed by the Master

Association since its organization against the portion of Property which is owned by the Member at that time, and the denominator of which is the total amount (excluding penalties and interest) assessed by the Master Association against all properties which at the time of dissolution are part of the Property. The year of dissolution shall count as a whole year for purposes of the preceding fractions.

- B. The Master Association may be dissolved upon a resolution to that effect being approved by a majority of the Board of Directors and by two-thirds (2/3) of the Members. In the event of incorporation by annexation or otherwise, of all or part of the Property by a political subdivision of the State of Florida, the Master Association may be dissolved in the manner set forth above.
- C. In no event shall the Master Association be dissolved, and any attempt to do so shall be ineffective, unless and until maintenance responsibility for the Surface Water or Stormwater Management System and discharge facilities located within the Property is assumed by an entity acceptable to SJRWMD, Florida Department of Environmental Regulation, or other governmental authority having jurisdiction, or other administrative regulation of similar import. Further, such dissolution shall require the prior approval of the ACOE.

#### XVII. MERGERS AND CONSOLIDATIONS.

Subject to the provisions of the Declaration applicable to the Property and to the extent permitted by law, the Master Association may participate in mergers and consolidations with other nonprofit corporations organized for the same purposes, provided that any such merger or consolidation shall be approved in the manner provided by Chapter 617, Florida Statutes as the same may be amended from time to time. For purposes of any vote of the Members required pursuant to said statutes, for so long as the Developer shall own any portion of the Property, any such merger or consolidation shall require the Developer's prior approval.
