Documents" (as that term is defined in that certain Declaration of Covenants, Conditions, Easements, and Restrictions for					
Calabay Crossing, as same may from time to time be amended or supplemented (the "Declaration"), to be recorded in the					
Public Records of Polk County, Florida). Capitalized terms used above or herein without definition shall have the same					
meanings given or ascribed to such terms in the Governing Documents. The Association shall have all the powers of a not					

for profit corporation organized under Chapter 617 of the Florida Statutes, Florida Not For Profit Corporation Act (the "Act"), subject, however, only to such limitations upon the exercise of such powers as are expressly set forth in the Governing Documents. The Association shall have the power to do any and all lawful things which may be authorized. assigned, required, or permitted to be done by the Association pursuant to the Governing Documents and/or the Act, including, but in no way limited to: (i) ownership, operation, management, administration, maintenance, repair, replacement, and insurance of the Common Areas; (ii) the levy and collection of Assessments; (iii) ownership and conveyance of property: (iv) establish rules and regulations: (v) to sue and be sued; (vi) to contract for services to provide for operation and maintenance of the surface water management system facilities if the Association contemplates employing a maintenance company; and (iii)(vii) to do and perform any and all acts which may be necessary or proper for, or incidental to, the exercise of any of the duties or powers of the Association as specified in the Governing Documents and/or under the Act. The Association shall operate, maintain and manage the Stormwater Management System in a manner consistent with District Permit Number 44026094-005, and applicable District rules, and shall assist in the enforcement of the restrictions and covenants contained herein. The Association shall levy and collect adequate assessments against members of the Association for the costs of maintenance and operation of the Stormwater Management System. The assessments shall be used for the maintenance and repair of the Stormwater Management System and mitigation or preservation areas, including but not limited to work within retention areas, drainage structures and drainage easements.
