ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF WALKERS GREEN HOMEOWNERS ASSOCIATION, INC.

AMENDED LANGUAGE:

Article 16 "Dissolution" shall be replaced/revised with the following highlighted:

ARTICLE 16 - DISSOLUTION

The Association may be dissolved with the assent given in writing and signed by holders of not less than three-fourths (3/4) of the total votes. Upon dissolution of the Association, other than incident to a merger or consolidation, the assets of the Association shall be dedicated to an appropriate public agency to be used for purposes similar to those for which the Association was created. In the event that such dedication is refused acceptance, such assets shall be granted, conveyed and assigned to any non-profit corporation, association, trust or other organization to be devoted to such similar purposes. In the event of termination, dissolution or final liquidation of the Association, the responsibility for the operation and maintenance of the surface water or stormwater management system must be transferred to and accepted by an entity which would comply with Rule 62-330.310, F.A.C., and Applicant's Handbook Volume I, Section 12.3, and be approved by the St. Johns River Water Management District prior to such termination, dissolution, or liquidation.
