# ARTICLE IX, NON-PROFIT NATURE.

### 9.1 NON-PROFIT NATURE

Sciences and Arts Minaret Academy Inc is organized exclusively for charitable and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(e)(3) of the Internal Revenue Code, or corresponding section of any future Federal tax code. No part of the net earnings of Sciences and Arts Minaret Academy Inc shall inure to the benefit of, or be distributable to, its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments in furtherance of the purposes set forth in the purpose clause thereof. Notwithstanding any other provision of this document, the corporation shall not carry on any other activities not permitted to be carried on (a) by any organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, corresponding section of any future tax code, or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Sciences and Arts Minaret Academy Inc is not organized and shall not be operated for the private gain of any person. The property of the corporation is irrevocably dedicated to its educational and charitable purposes. No part of the assets, receipts, or net earnings of the corporation shall inure to the benefit of, or be distributed to, any individual. The corporation may, however, pay reasonable compensation for services rendered, and make any payments and distributions consistent with these Articles.

# 9.02 PERSONAL LIABILITY

No officer or director of this corporation shall be personally liable for the debts or obligation of Sciences and Arts Minaret Academy Inc of any nature whatsoever, nor shall any of the property or assets of the officers or directors be subject to the payments of the debts or obligations of this corporation: provided, however, such relief from liability shall not apply in any instance where such relief is inconsistent with any provision of the Internal Revenue Code applicable to corporations as described in section 501(c)(3) of the Internal Revenue Code.

# 9.03 DISSOLUTION

Upon termination or dissolution of Sciences and Arts Minaret Academy Inc. any assets lawfully available for distribution, after paying or making provision for the payment of all of the liabilities and obligations of the corporation and for necessary expenses thereof, shall be distributed to such organization or organizations organized and operated exclusively for charitable purposes as shall at the time qualify as exempt organizations described in section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, as the Board of Directors shall determine. The organization or organizations have a charitable purpose which, at least generally, includes a purpose similar to the terminating or dissolving corporation. In no event shall any of the assets or property be distributed to any director or officer, or any private individual.

# 9.04 RESTRICTED ACTIVITIES

No substantial part of the corporation's activities shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in or intervene (including the publishing or distribution of statements) in any political campaign on behalf of or in opposition to any candidate for public office.

# ARTICLE X, DURATION

10.01 DURATION

The duration of the corporation is perpetual.

### ARTICLE XI, MEMBERSHIP

11.01 MEMBERS

Sciences and Arts Minaret Academy Inc shall have no members.

## ARTICLE XII, AMENDMENTS

12.01 AMENDMENTS

Any amendment to the articles of incorporation may be adopted by the approval of two-thirds the Board of Directors.
