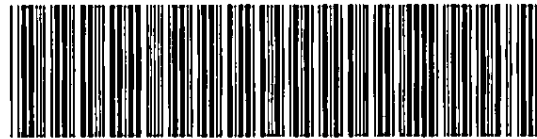

# **ARTICLES OF INCORPORATION OF**

## **ISKCON OF JACKSONVILLE, INC.**

*Pursuant to the provisions of Chapter 617 of the Florida Statutes, the undersigned Florida nonprofit corporation adopts the following restatement of its articles of incorporation.*

### **ARTICLE I**

#### **Name**

The Name of this corporation shall be:

ISKCON OF JACKSONVILLE, INC.

### **ARTICLE II**

#### **Principal Place of Business and Mailing Address**

The initial principal office of this Corporation shall be located at:

### **ARTICLE III**

#### **Purposes**

The purposes for which the Corporation is organized are exclusively religious, charitable, and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1954 or corresponding provision of any future United States Internal Revenue law, and shall be to fulfill the will of His Divine Grace A.C. Bhaktivedanta Swami Prabhupada as follows:

(a) To systematically propagate spiritual knowledge to society at large and to educate all peoples in the techniques of spiritual life in order to check the imbalance of values in life and to achieve real unity and peace in the world;

(b) To propagate a consciousness of the Lord Sri Krishna revealed in Bhagavad-gita, Srimad Bhagavatam;

(f) To bring the members closer together for the purpose of teaching a simpler, more natural way of life;

(g) With a view towards achieving the aforementioned purposes, in both print and electronic media, to publish and distribute periodicals, magazines, books and other writings;

(h) To receive, administer and distribute funds, and to do all other things necessary and proper in furtherance of the above stated purposes.

## **ARTICLE IX**

### **Limitation of Corporate Powers**

No part of the net earnings of the Corporation shall inure to the benefit of or be distributable to any director or officer of the Corporation, or any other private person, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered to or for the Corporation and to make payments and distributions in furtherance of the purposes set forth in Article III hereof.

This corporation is organized and operated exclusively for religious, charitable, and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

The corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contribution to which are deductible Section 170(c)(2) of the Internal Revenue Code.

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of, or in opposition to, any candidate for public office.

## **ARTICLE X**

### **Distribution of Assets Upon Dissolution**

The property of this corporation is irrevocably dedicated to religious, charitable, and educational purposes and no part of the net income or assets of the organization shall ever inure to the benefit of any director, officer or member thereof or to the benefit of any private person, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered to or for the Corporation and to make payments and distributions in furtherance of the purposes set forth in Article III hereof.

On the dissolution or winding up of the corporation, its assets remaining after payment of, or provision for payment of, all debts and liabilities of this corporation, shall be distributed to a

nonprofit fund, foundation, or corporation which is organized and operated exclusively for religious, charitable, and educational purposes and which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code.


