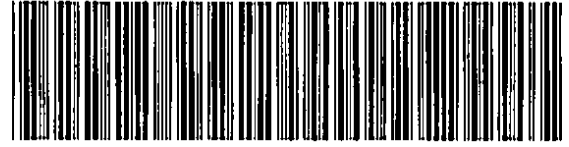

## ARTICLES OF INCORPORATION

In compliance with Chapter 617, F.S., (Not for Profit)

### ARTICLE I NAME

The name of the corporation shall be: INNOVA CREDIT COUNSELING, INC.

### ARTICLE III PURPOSE

The specific purpose for which this corporation is organized is:

Innova Credit Counseling, Inc. is organized exclusively to operate as a charitable corporation within the meaning of section 501(c)3 of the Internal Revenue Code of 1986, as amended, or corresponding provisions of any later federal tax laws (the "code"), by providing financial education, counseling and resources to distressed individuals who require assistance with budgeting and money management.

In furtherance of such purposes, the corporation may, inter alia, provide (i) counseling on credit, money management and budgeting matters; (ii) housing counseling, focusing on the issues faced by homeowners that are experiencing financial difficulties and individuals attempting to obtain credit to purchase a home; and (iii) the distribution of credit, money management and budgeting related educational resources, information, courses and materials.

The corporation may engage in any lawful activities or transact any lawful business for which corporations may be incorporated under the Florida not for profit corporation act, not inconsistent with those exercisable by a corporation in conformance with section 501(c)3 of the code. Furthermore, all funds of the corporation and any monies from its operations shall be used in the furtherance of the purposes set forth above, and no benefits shall inure to any private parties, except as incidental to the purposes and objectives of the corporation.

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in sections 501(c)3 and 170 (c)(2) of the Internal Revenue Code of 1986 or corresponding sections of any prior or future Internal Revenue Code, or to the federal, state or local government for exclusive public purpose.

All powers exercised herein shall be in furtherance of the purposes set forth above and shall, at all times, be in conformance with the provisions of section 501(c)3 of the code.
