



Articles of Incorporation of

Mothers United International Inc.

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under the section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The business activity for said organization is as follows: To serve as an agent of change, to further the United Nations sustainable development goals locally and abroad. Our center piece to accomplish this mission is to focus on Sustainable Development Goal 4: Quality Education. We believe that all change begins when people have access to a quality education. In fact, what we have discovered is that all 17 of the sustainable development goals effect whether or not a child has access to a quality education, and the issues represented in each development goal stems from the fact that the adult population did not have access to a quality education when they were children. Quality Education does not exist in a bubble. So, for this reason we will have activities that directly and indirectly effect goal #4 (gender equality) which include:

- No Poverty
- Zero Hunger
- Good-Health and well being
- Gender equality
- Clean water and sanitation
- Industry and infrastructure
- Decent work and economic growth
- Partnerships for the goals

The programs that we have up and going now are an online learning platform where we educate children in a variety of subjects that have people of color as the focal point. This program is free. The other program that we have is the Education Stakeholders Program. This is our international initiative to help struggling schools, their parents, and the communities they serve in West Africa. This project is currently being funded by friends and family of the students that attend our free online classes. We have it set up this way because we believe in having a non-profit that follows the social enterprise model. Once we obtain our official non-profit statues, we are planning to reach out to a wider audience for participation, and funding of our projects.

No part of the net earnings of this organization shall inure to the benefit of, or be distributable to, its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth herein. No substantial part of the activities of this corporation shall be the carrying on of

propaganda, or otherwise attempting to influence legislation, and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of this document, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c) (2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Upon the dissolution of this corporation, assets remaining shall be distributed for one or more exempt purposes within the meaning of Section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed by a Court of Competent Jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
