ARTICLE III PURPOSE

NURSE PRACTITIONER COUNCIL OF THE TREASURE COAST INC is organized exclusively for charitable and educational purposes to promote social welfare within the meaning of section 501(c)(4) of the Internal Revenue Code of 1986 or the corresponding provisions of any further United States Internal Revenue Law.

They shall be concerned with the health and wellness of the people of the State of Florida and promote the visibility and unity of nurses engaged in advance nursing practice as Nurse Practitioners. This will be accomplished by the provision of quality evidence-based educational programs, networking opportunities for its members, promoting the role of the Nurse Practitioner, legislative policy advocacy and community outreach programs.

Notwithstanding any other provisions of these articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under section 501(c)(4) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(4) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
