ARTICLES OF INCORPORATION OF YA BY THE BAY, INC. A Florida Nonprofit Corporation

The undersigned, all of whom are citizens of the United States, desiring to form a nonprofit Corporation under the Florida Not-For-Profit Corporation Act, Florida Statutes Chapter 617, do hereby certify:

ARTICLE 1 - Name

The name of the Corporation shall be YA By the Bay, Inc. (hereinafter referred to as the "Corporation").

ARTICLE 2 – Principal Office

The address of the principal office and the mailing address of the Corporation is: 4898 Tivoli Drive, Wesley Chapel, 33543, Pasco County, State of Florida.

ARTICLE 3 - Purpose

The purpose of the Corporation is to engage in any lawful act or activity for which corporations may be organized under the Florida Not-For-Profit Corporation Act, however, that the corporation shall only engage in acts or activities that are consistent with and in furtherance of its 501(c)(3) tax-exempt purposes, which are described in other provisions of these articles.

The specific purposes for which the Corporation is organized are: to support, educate, and grow the young adult literary community in the greater Tampa Bay area. The means for accomplishing this includes, but is not limited to, hosting an annual young adult book festival open to the general public featuring panels and workshops presented by renowned authors and leaders, and awarding scholarships to teenagers for their creative writing.

The Corporation is organized and operated exclusively for charitable, educational, and literary purposes within the meaning under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE 4 - Manner of Election

Directors shall be elected or appointed as set forth in the Bylaws of the Corporation.

ARTICLE 5 - Initial Board of Directors

ARTICLE 10 - Limitations on Political Activities

No substantial part of the activities of the Corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Section 501(h) of the Internal Revenue Code), and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.

ARTICLE 11 - Additional Provisions

Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE 12 – Dissolution

Upon the dissolution of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code or shall be distributed to the federal government, or to a state or local government, for a public purpose.
