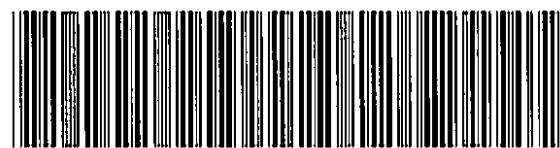

ARTICLE I. - NAME

The name of the Corporation is YOUNG ISRAEL OF TAMPA, INC.

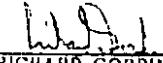

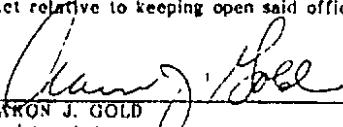

ARTICLES OF AMENDMENT TO

ARTICLES OF INCORPORATION OF

YOUNG ISRAEL OF TAMPA, INC.

Pursuant to the provisions of the Florida General Corporation Act, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. Article III, - Purpose - of the Articles of Incorporation is hereby revoked and the following is substituted in its place:

ARTICLE III. - PURPOSE

The purposes for which this Corporation is organized are:

(a) To establish and maintain a Synagogue for divine worship and religious observance according to the tenets and precepts of Orthodox Judaism;

(b) The purposes for which the Corporation is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue law.

2. Article VIII, is hereby added to the Articles of Incorporation to read as follows:

ARTICLE VIII.

Notwithstanding any other provision of these Articles, this organization shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue law.

3. Article IX, is hereby added to the Articles of Incorporation to read as follows:

ARTICLE IX.

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in Sections 501(c)(3) and 170(e)(2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future Internal Revenue Code, or to the Federal, State, or local government for exclusive public purpose.

4. The foregoing Amendments were adopted by the Board of Directors of the Corporation (as no members have been admitted yet) on October 5, 1987.
