**ARTICLES OF AMENDMENT  
TO THE  
ARTICLES OF INCORPORATION OF  
BOCA RATON REPUBLICAN CLUB, INC.**

FIRST: Article 1 is amended to reflect the new name of the corporation:

**ARTICLE I**

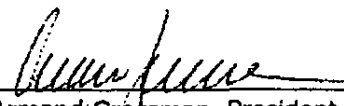
**BOCA RATON REGIONAL REPUBLICAN CLUB, INC.**
