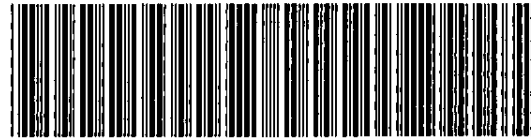



# **PANAMA CITY BEACH CHAMBER OF COMMERCE BYLAWS**

## **ARTICLE I: GENERAL**

### **SECTION 1: NAME**

This organization is incorporated under the laws of the State of Florida and shall be known as the Panama City Beach Chamber of Commerce, Incorporated.

### **SECTION 2: PURPOSE**

Panama City Beach Chamber of Commerce is organized to achieve the objectives of: 1) Preserving the competitive enterprise system of business by: Creating a better understanding and appreciation of the importance of business people and a concern for their problems; educating the business community and representing them in the city, county, state and national legislative and political affairs; preventing or addressing controversies which are detrimental to expansion and growth of business and the community if they arise; creating a greater appreciation of the value of a more liberal investment of substance and self on behalf of the interests of competitive business; 2) Promoting business, tourism and community growth: promoting economic programs designed to strengthen and expand the income potential of all business within the trade area; promoting programs of a civic hospitality, social and cultural nature which are designed to increase the functional and aesthetic values of the community; and discovering and correcting abuses which prevent the promotion of business expansion and community growth.

### **SECTION 3: DEFINITION OF PANAMA CITY BEACH CHAMBER**

Panama City Beach Chamber shall mean to include the area of dominant influence on behalf of the organization's members.

### **SECTION 4: LIMITATION OF METHODS**

Panama City Beach Chamber of Commerce shall observe all local, state and Federal laws, which apply to a non-profit organization as defined in Section 501(c)(6) of the Internal Revenue Code.

## **ARTICLE II: MEMBERSHIP**

All memberships are subject to the approval of the Board of Directors. The qualifications for membership include the following:
