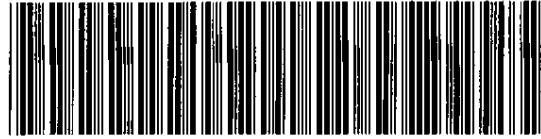



ARTICLES OF INCORPORATION

OF

IGLESIA BAUTISTA FUNDAMENTAL HISPANA, INC.

We, the undersigned, hereby associate ourselves for the purpose of becoming a non-profit corporation under the laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida providing for the formation, liability, rights, privileges and immunities of a corporation not for profit.

ARTICLE I

NAME OF CORPORATION

The name of this corporation is Iglesia Bautista Fundamental Hispana, Inc. (Spanish Fundamental Baptist Church)

ARTICLE II

PURPOSE

The purpose of the corporation is to establish and maintain a church and to provide a place of public worship for the same in the City of Margate, County of Broward and State of Florida;

To establish, maintain and conduct schools for religious instruction, mission churches, mission stations, and to further other religious, educational and charitable work to that end, adopt and establish by-laws and make all rules and regulations deemed necessary and expedient for the management of its affairs in accordance with the law and not inconsistent with these Articles of Incorporation;

To acquire, buy, hold, own, sell, exchange, convey, lease, or otherwise dispose of goods, chattels, effects and merchandise;

To mortgage, lease, hypothecate, convey, exchange, and dispose of lands and chattels, to acquire, by gift, annuity, bequest, or otherwise, property, both real and personal or otherwise, and to promote the diffusion of religious literature and education loyal

to the doctrines of the Bible;

To do anything and everything pertinent to the above.

### ARTICLE III

#### QUALIFICATION OF MEMBERS

Persons who believe in repentance towards God, and faith in Jesus Christ as their Saviour and Lord, and who are willing to confess Him publicly as Lord and follow Him in baptism by immersion and to observe the ordinances of Christ and to be governed by His laws and the Church, are qualified and eligible for membership in this church corporation.

The manner of admission to membership shall be by profession of faith as hereinbefore provided, completion of a new members' class or transfer by letter from another fundamental church, and approval by the Board of Directors.

### ARTICLE IV

#### BY LAWS

By-laws of the corporation are to made, offered, and rescinded by a majority of the qualified members of the Church, present and voting at a regular or special business meeting.

### ARTICLE V

#### CORPORATE EXISTENCE

This corporation shall have perpetual existence unless sooner dissolved by law.

### ARTICLE VI

#### OFFICERS

The affairs of the corporation shall be managed by a President, Vice-President, Secretary and Treasurer, as authorized by the Board of Directors. Said officers shall be elected at the annual meeting of the Board of Directors which shall immediately follow the annual meeting of the members. The first officers of the corporation, who shall serve until such time as they resign,

are removed, or their successors are elected, shall be:

#### ARTICLE VII

##### NUMBERS OF DIRECTORS

This corporation shall have no less than three (3) nor more than thirty (30) directors. The directors shall be elected at the annual meeting of the membership as provided by the By-Laws.

ARTICLE X

AMENDMENT

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors at a meeting in which a quorum shall be present.

ARTICLE XI

PRINCIPAL PLACE OF BUSINESS

The initial post office address of the principal office of this Corporation in the State of Florida is 6905 Royal Palm Blvd., Margate, FL. 33063.

The Board of Directors may from time to time move the principal office to any other address in Florida and establish branch offices at any other place within or without the State of Florida.

ARTICLE XII

DISSOLUTION

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in sections 501 (c) (3) and 170 (c) (2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future Internal Revenue Code, or to the Federal, State, or Local government for exclusive public purpose.

ARTICLE XIII

PROHIBITED ACTIVITIES


Notwithstanding any other provision of these articles, this Corporation shall not carry on any other activities not permitted to be carried on by (a) a corporation exempt from Federal income tax under section 501 (c) (2) of the Internal Revenue Code of 1954 or the corresponding provisions of any future United States Internal Revenue Law or (b) a corporation contributions which are deductible under section 170 (c) (2) of the Internal Revenue Code of 1954 or any other corresponding provisions of any future United States Internal Revenue Law.



May 15, 1988

AMENDMENT AFFIDAVIT

With today's date, after being announced, in accordance to our Constitution and By-laws, we joined in an extraordinary assembly with the purpose of constituting two amendments to our Constitution and By-Laws in order to comply with the demands of the Internal Revenue Service, numbered 501(c) (3).

AMENDMENTS

FIRST AMENDMENT

- A. The purposes for which the Corporation is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of section 501(c) (3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue law.
- B. Notwithstanding any other provision of these articles, this organization shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal Income tax under section 501(c) (3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue law.

Please note our ARTICLE XIII of our Constitution, code Section 501(c) (2) does not apply.

All of the above was presented for vote and was passed by 67% of the members present. It was also passed by the Board of Directors on a meeting on Saturday, May 9, 1988.
