### THE AMENDMENTS

The Articles of Incorporation of the IGLESIA BAUTISTA FUNDAMENTAL HISPANA, INC. are hereby amended as follows:

1. **Article I of the Articles of Incorporation is hereby replaced. The new Article I reads as follows:**

Qualification of Members


Qualification and eligibility for membership in this church corporation and the manner of admission to membership shall be as defined in the church's Constitution.
