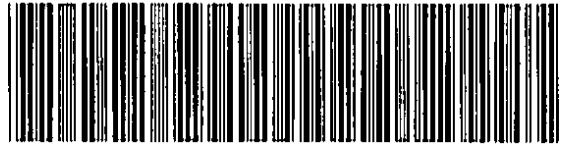

The undersigned hereby adopts the following articles of incorporation in Compliance with Chapter 617, F.S., (Not for Profit).

#### Article 1 Name

The name of this corporation shall be **Reliant Global Outreach, Inc.**

#### Article 2 Principal Office

#### Article 3 Purpose

The specific purpose for which the corporation is initially organized is to be a faith-based community development organization serving local and international communities by engaging in a broad range of strategies that promote health, education, and development; license and ordain ministers of the gospel; provide religious, charitable and humanitarian services; support missions; and to also engage in activities which are necessary, suitable or convenient for the accomplishment of that purpose, or which are incidental thereto or connected therewith which are consistent with Section 501(c)(3) of the Internal Revenue Code. **This corporation is organized and operated exclusively for charitable and religious purposes within the meaning of Section 501(c)(3), Internal Revenue Code.**

#### Article 4 Manner of Appointing Directors

Directors shall be appointed in the manner set forth in the bylaws. Directors may be removed and the vacancies shall be filled in the manner provided by the bylaws.

#### Article 5 Initial Directors

The directors named in these articles shall serve as initial directors for the ensuing year, or until the first meeting of the corporation, and any vacancies before then shall be filled in the manner set forth in the bylaws.

## **Article 9 Term and Dissolution**



## **Article 10 Non Profit Organization**


