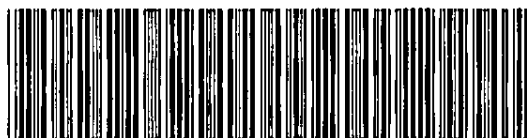

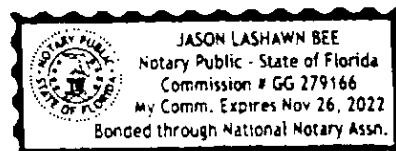
This letter is in regards to my request to dissolve my exiting company, Women After God's Own Heart, LLC and to release the business name.


