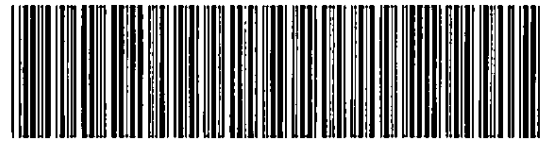

Amendment to Articles of Incorporation
