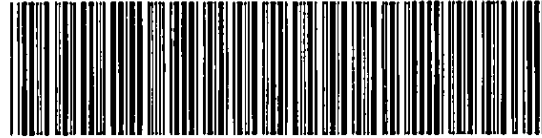

**ARTICLES OF INCORPORATION  
OF  
CRAWFORD WILLIAMS FOUNDATION, INC.**

The undersigned, a citizen of the United States, in order to form a corporation not for profit in accordance with Chapter 617, Florida Statutes, adopts the following Articles of Incorporation.

**ARTICLE I**

**NAME:** The name of the Corporation shall be: CRAWFORD WILLIAMS FOUNDATION, INC.

**ARTICLE II**

**PRINCIPAL OFFICE:** The principal place of business and mailing address of this corporation shall be: 628 S.E. 5<sup>th</sup> Street, #5, Delray Beach, FL 33483.

**ARTICLE III**

**PURPOSE:** This corporation is organized exclusively for charitable and educational purposes, and the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the U.S. Internal Revenue Code and corresponding section of any future federal tax code.

#### **ARTICLE IV**

**MANNER OF ELECTION:** The manner in which the directors are elected or appointed shall be as stated in the bylaws.

#### **ARTICLE V**

**INITIAL REGISTERED AGENT AND STREET ADDRESS:** The name and Florida street address of the registered agent are T.N. Murphy, Jr., Esq., 4800 N Federal Highway, Suite E-100, Boca Raton, FL 33431.

#### **ARTICLE VI**

**INITIAL DIRECTORS:** This Corporation shall have three (3) directors initially. The number of directors may be either increased or diminished from time to time by the bylaws, but shall never be less than one (1). The name and address of the directors are:

## **ARTICLE VII**

**INCORPORATOR:** The name and address of the Incorporator are T.N. Murphy, Jr., Esq., 4800 N Federal Highway, Suite E-100, Boca Raton, FL 33431.

## **ARTICLE VIII**


**NET EARNINGS; CORPORATE ACTIVITIES:** No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of this corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provisions of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, or any corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or any corresponding section of any future federal tax code.

## **ARTICLE IX**

**DISTRIBUTION OF ASSETS ON DISSOLUTION:** Upon the dissolution of this corporation, assets shall be distributed for one or more exempt purposes, within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a

public purpose. Any such assets not so disposed of shall be disposed of by the Circuit Court for the county in which the principal office of the corporation is then located. Exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

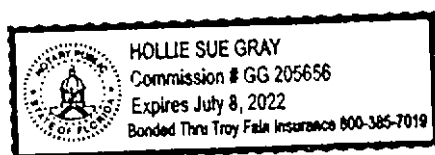

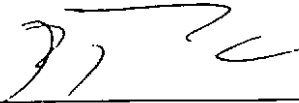
