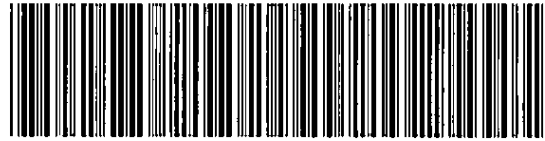

ARTICLES OF INCORPORATION

ARTICLE I

NAME

1.01 Name

The name of this corporation shall be **Meryemana A C, Inc.** The business of the corporation may be conducted as (**Meryemana A C, Inc, or other names**) or **Meryemana A C, Inc.**

ARTICLE II

DURATION

2.01 Duration

The period of duration of the corporation is perpetual.

ARTICLE III

PURPOSE

3.01 Purpose

Meryemana A C, Inc. is a non-profit corporation and shall operate to support disadvantaged individuals around the world, consistent with Section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future Federal tax code.

Meryemana A C, Inc.'s purpose is to: provide support and education to disadvantaged individuals through social media channels and the organization's website to provide facts, statistics, and other related data on causes, current efforts, and solutions to bring to them awareness of their human rights in places where the people are in the greatest need.

Our programs include sending out ambassadors to raise social consciousness about issues on a local and global level. To provide fundraising events to deliver immediate relief and assistance to individuals, regardless of their race, ethnicity, or religion.

To maximize our impact, we may seek to collaborate with other non-profit organizations which fall under the 501 (c)(3) section of the Internal Revenue Code.

At times, per the discretion of the board of directors, we may provide internships or volunteer opportunities which will provide opportunities for involvement in said activities and programs to have a greater impact for change.

3.02 Public Benefit

Meryemana A C, Inc. is designated as a public benefit corporation.

ARTICLE IV

NON-PROFIT NATURE

4.01 Non-profit Nature

Meryemana A C, Inc., is organized exclusively for charitable purposes including, for such purposes, as the making of distributions to organizations that qualify as exempt organizations under section 501 (c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. No part of the net earnings of **Meryemana A C, Inc.** shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof.

No part of the activities of the corporation shall be to conduct propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of this document, the corporation shall not carry on any other activities not permitted to be carried on (a) by any organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Meryemana A C, Inc., is not organized and shall not be operated for the private gain of any person. The property of the corporation is irrevocably dedicated to its educational and charitable purposes. No part of the receipts, or net earnings of the corporation shall inure to the benefit of directors or be distributed to any individual. The corporation may, however, pay reasonable compensation for services rendered, and make other payments and distributions consistent with these Articles.

4.02 Personal Liability

No officer or director of this corporation shall be personally liable for the debts or obligations of **Meryemana A C, Inc.**, nor shall any of the property or assets of the officers or directors be subject to the payment of the debts or obligations of this corporation.

4.03 Dissolution

Upon termination or dissolution of **Meryemana A C, Inc.**, any assets lawfully available for distribution shall be distributed to one (1) or more qualifying organizations described in Section 501(c)(3) of the Internal Revenue Code of 1986 (or described in any corresponding provision of any successor statute) which organization or organizations have a charitable purpose.

The Organization to receive the assets of the **Meryemana A C, Inc.** hereunder shall be selected by the discretion of a majority of the managing body of the **Meryemana A C, Inc.**

4.03 Prohibited Distributions

No part of the net earnings, properties of the directors of this corporation, on dissolution or otherwise, shall inure to the benefit of, or be distributable to, its directors, officers or other private person or individual, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III, Section 3.01.

4.04 Restricted Activities

No substantial part of the corporation's activities shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene (including the publishing or distribution of statements) in any political campaign on behalf of or in opposition to any candidate for public office.

4.05 Prohibited Activities

Notwithstanding any other provision of these Articles, the corporation shall not carry on any activities not permitted to be carried on (I) by a corporation exempt from federal income tax as an organization described by Section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (II) by a corporation, contributions to which are deductible under Section 170 (c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE V

BOARD OF DIRECTORS

5.01 Governance

Meryemana A C, Inc. shall be governed by its board of directors.

5.02 Initial Directors


