

Latin American Future, Inc. 87-3128275 Ref. # W21000153064 ARTICLE III – PURPOSE

This organization is organized exclusively for charitable, religious, educational and scientific purposes and will promote the Latin American culture, heritage and highlight the achievements and contributions in the State of Florida. It will include the making of distributions to organizations that qualify as exempt organizations under section 501 © (3) of the Internal Revenue Service Code, or corresponding section of any future federal tax code.

No part of the net earnings of this organization shall inure to the benefit of, or be distributable to, its members, trustees, officers or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof.

No substantial part of the activities of this organization shall be the carrying on propaganda, or otherwise attempting to influence legislation, and this organization shall not participate in, or intervene in any political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under section 501 © (3) of the IRS code as now enacted or hereafter amended.

Upon dissolution of this corporation, assets remaining shall be distributed for one or more exempt purposes within the meaning of section 501 © (3) of the IRS code or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government for a public purpose. Any such assets not distributed not disposed of shall be disposed by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE IV – MANNER OF ELECTION

The corporation shall have no voting members. The



corporation's by laws. No director shall have any right, title or interest in or to any property of the corporation.

Members may be elected to the Board upon recommendation of the Membership Committee and an affirmative half plus one or majority of the voters of the Board. A member may be elected for a subsequent consecutive term of office if the Membership Committee so recommends and upon half lus one or majority votes by the Board.

Members of the Board may be elected to two years' terms by the Board upon recommendation by the membership Committee.
