

### CHANGES TO ARTICLES OF INCORPORATION

### Article III of the Articles of Incorporation should be revised as follows:

The Golden Angel Foundation, Inc. is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations described under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of future federal tax code. Golden Angel Foundation, Inc. is organized to operate a charitable foundation that provides financial and educational assistance to current, alumni, honorary, and future U.S. Army Golden Knight team members or their extended family; extended family being parent, children, dependents, and grandchildren.

# Need to add an additional article to the Articles of Incorporation

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Upon the dissolution of the organization, after paying or adequately providing for the debts and obligations of the organization, the remaining assets shall be distributed to an organization(s) exempt under Section 501(c)(3) of the Internal Revenue Code upon majority vote of the Executive Board members present at the last meeting of the members. Further, no officer or director of the Golden Angel Foundation, Inc. or their family members as described in Internal Revenue Code Section 4946(a) shall be entitled to share in any assets upon dissolution of the organization.
