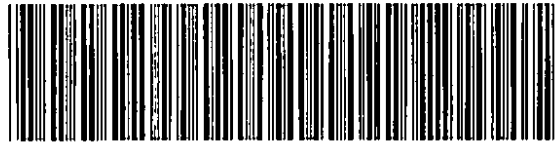

The Halo Project of Southwest Florida Inc. is organized exclusively for charitable, religious, and educational purposes
including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section
501(c)(3) of the International Revenue Code, or corresponding section of any future federal tax code. No part of the earnings
of The Halo Project of Southwest Florida Inc. shall inure to the benefit of, or be distributable to its members, trustees,
officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable

compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause herof.

Notwithstanding any other provision of this document, the corporation shall not carry on any other activities not permitted to be carried on (a) by any organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

The Halo Project of Southwest Florida Inc. is not organized and shall not be operated for the private gain of any person. The property of the corporation is irrevocably dedicated to its educational and charitable purposes. No part of the assets, receipts, or net earnings of the corporation shall inure to the benefit of, or be distributed to any individual. The corporation may, however, pay reasonable compensation for services rendered, and make other payments and distributions consistent with these Articles.

Upon termination or dissolution of The Halo Project of Southwest Florida Inc., any assets lawfully available for distribution shall be distributed to one (1) or more qualifying organizations described in Section 501(c)(3) of the Internal Revenue Code of 1986 (or described in any corresponding provision of any successor statute) which organizations have a charitable purpose which, at least generally, includes a purpose similar to the terminating or dissolving corporation.

The organization to receive the assets of The Halo Project of Southwest Florida Inc. hereunder shall be selected by the discretion of a majority of the managing body of The Halo Project of Southwest Florida Inc. and if it members cannot so agree, then the recipient organization shall be selected pursuant to a verified petition in equity filed in a court of proper
