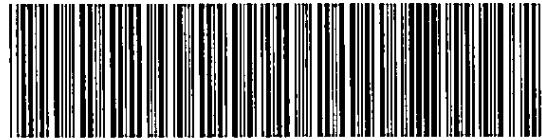

ARTICLES OF INCORPORATION

In compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I: **NAME:** The name of the corporation shall be:

Climate Summer Organizing Committee, Inc.

ARTICLE II: **PRINCIPAL OFFICE:** The principal street address and the principal mailing address of the corporation are:

~~ARTICLE III: PURPOSE:~~ The purpose of the organization shall be to organize a coalition of other nonprofit organizations, together with motivated individuals and organizations of any nature, to mount a campaign, on a nonpartisan basis, of canvassing and organizing public support to reduce the use of fossil fuels and the generation of greenhouse gases and to replace them with renewable energy sources in order to avoid the effects of a dangerous warming of the earth's atmosphere.

The purpose shall include all the activities that are required to organize, promote, publicize, and carry out organizing such a coalition, including if necessary, the actual planning, funding, and mounting of the campaign and establishing and implementing the means to follow through and institutionalize the permanent means and methods of promoting the transformation from a carbon-based economy to a renewable-energy-based economy.

The purpose shall include carrying out any other kinds of activities permitted to tax- exempt organizations under the Internal Revenue Code in furtherance of the general aims spelled out above but shall exclude any activities not permitted to organizations under Section 501(c)(3).

ARTICLE IV: **MANNER OF ELECTION:** The members of the Board of Directors shall elect the membership of the Board at an annual election at the time and for the terms specified in the Bylaws.
