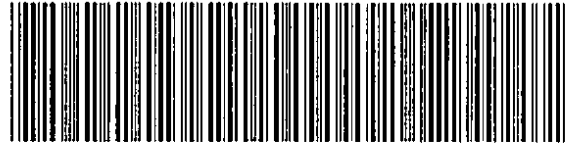

No part of the net earnings of the corporation shall inure to the benefit of any officer/director of the corporation; and upon dissolution of the corporation, the Board of Directors shall, after paying or making provision of for payment of all the liabilities of the corporation, dispose of the residual assets of the corporation exclusively for religious organizations described in Section 501(c)3 and 170(c)2 of the IRS Code of 1986 or corresponding Section of any future IRS Code. Any such assets not so disposed of shall be disposed by the Superior Court of the county in which the prinicple office of the corporation is then located, for such purposes or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
