### ARTICLES OF INCORPORATION OF HBCU Relays, Inc. A FLORIDA NONPROFIT CORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

#### **ARTICLE I NAME**

The name of the corporation shall be: HBCU Relays, Inc.

#### ARTICLE II PRINCIPAL OFFICE
