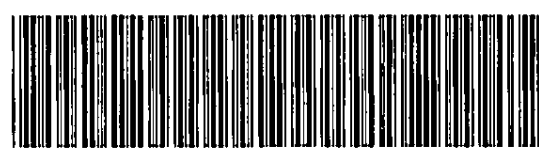

**ARTICLES OF INCORPORATION
FOR
SISTERS MINISTRY, INC.**

The undersigned incorporator is an individual over the age of 18 years of age and adopt the following Articles of Incorporation to form a nonprofit corporation.

ARTICLE I - NAME

The name of the Corporation shall be **Sisters Ministry, Inc.**

ARTICLE II - PRINCIPAL OFFICE

The place in Florida where the principal office and mailing address of the corporation is to be located at **35 West 7th Street, Apopka, FL 32703**

ARTICLE III - PURPOSE

The purpose for which this Corporation is organized and operated exclusively for charitable, religious, educational, and scientific purposes as specified in Section 501(c)(3) of the Internal Revenue Code, including for such purposes, the making of distributions to individuals, families, ministries, or organizations that qualify.

It is the Holy Spirit which forms the Body of Christ. The membership of this Corporation shall be composed of persons who have been called from the world by the confession of their sins and the proclamation of their faith in Jesus Christ as Lord and Savior.

Women are hurting; this corporation wants to empower women through the Word of God. It is important that women realize their value through the teaching of God's Word.

More functions of this corporation:

- To conduct monthly services, (by the direction and guidance of the Holy Spirit in accordance with the Holy Bible, the irreversible Word of God) with women from all denominations and all walks of life, coming together in prayer, praise, worship, and service to God.
- To teach women the promises of God through His Word and minister the Word of God to the faithful.
- To assist women (men) whether it be financial support and unspiritual support (bills, clothing, food, tuition, books, etc. where needed).

- To raise and assist in raising funds; receive and accept gifts and hold the same for the purpose of the Corporation and its work.
- To accept property and donation in trust for religious or charitable purposes.
- To offer mentoring and spiritual guidance to hurting, devastated, misused, mistreated, and spiritually dead women.
- To reach out and help women to make their homes, workplace, neighborhood, and present recommended programs to the appropriate decision-making bodies in the community.
- To identify (with an invitation to be part of the ministry) individual strengths in others whom we can reach with the gospel of Jesus Christ that will help to enhance the community, their ministries and help them grow closer to God.
- To teach women to bond together in Christian love, helping them realize how much God cares for them and that we are all SISTERS; a part of the same body working together for a better world.
- To contribute regularly and continuously our time and talent in support of God's ministry through Teaching, Prayer and Faith.
- To come together with other church groups and religious organizations for the building of God's Kingdom.

ARTICLE IV - MANNER OF ELECTION

The power of the Corporation shall be exercised by or under the authority of the Executive Board of Directors. The President, Vice President, Secretary and Treasurer cannot be voted out at any time; can only resign (or be asked to resign for ungodly conduct) and at time of their resignation the President and Vice President reserves the right to select their predecessors.

Director(s) shall be nominated by President or Vice President and approved by a majority vote from the Executive board, as necessary.

The business and affairs of the Corporation shall be managed under the direction of the Executive Board. The number of Board members may be increased or decreased from time to time by a majority vote of the Board, but at no time shall there be fewer than Five (5) members of the Board.

Members of the initial Executive Board shall serve until the first annual meeting, at which their successors will be duly elected and qualified or removed as provided in the bylaws.

The duration of the corporate existence shall be permanent until disbanding as shown in the Bylaws.

ARTICLES V - INITIAL DIRECTORS AND/OR OFFICERS

This corporation shall have an Executive Board of Directors. The eligibility, rights and obligations of the board will be determined by the organization's bylaws.

The management of the affairs of the corporation shall be vested in the board of directors, as defined by the corporation's bylaws. No board member shall have any right, title, or interest in or to any property of the corporation.
