I, the undersigned, being of legal age and a natural person, do hereby subscribe to, acknowledge and file the following Articles of Incorporation under the Florida Business Corporation Act, Chapter 607, Florida Statutes, with the intent and for the purpose of creating a not-for-profit corporation under the laws of the State of Florida.

**ARTICLE I
NAME, PRINCIPAL OFFICE & MAILING ADDRESS**

**ARTICLE II
CORPORATE ACTIVITIES, PURPOSE & POWERS**


