The undersigned hereby adopts the following articles of incorporation in Compliance with Chapter 617, F.S., (Not for Profit).

Article 1 Name

The name of this corporation shall be Hearts of Gold Ministry, Inc.

Article 3 Purpose

The specific purpose for which the corporation is initially organized is to be a faith-based organization serving our community by engaging in a broad range of strategies that promote mental health, education, and development, license and ordain ministers of the gospel, provide religious, charitable and humanitarian services, support missions and to also engage in activities which are necessary, suitable or convenient for the accomplishment of that purpose, or which are incidental thereto or connected therewith which are consistent with Section 501(c)(3) of the Internal Revenue Code.
