ARTICLES OF INCORPORATION

OF

Digital Tomosynthesis Society, Inc. a Florida Not-for-Profit corporation

Notice is hereby given that the undersigned incorporator, being of full age, for the purpose of forming a corporation not-for-profit, without capital stock, under the provisions of Chapters 607 and 617, Florida Statutes, do hereby accept all rights, privileges, benefits and obligations conferred and imposed by said law, and do hereby make, subscribe, acknowledge and file these Articles of Incorporation.

ARTICLE I - NAME

The name of this corporation is as follows:

Digital Tomosynthesis Society, Inc.

ARTICLE II - PRINCIPAL OFFICE, REGISTERED OFFICE AND AGENT

The street address of the principal office of the corporation is 3201 N Federal Hwy, Suite 212, Oakland Park, FL 33306, and the name of the registered agent of this corporation and address of the registered agent is: **REVIS, HERVAS & GOLDBERG P.A.** located at 1792 Bell Tower Lane, Weston, Florida 33326. The Certificate of Designation of Registered Office/Registered Agent attached hereto is incorporated herein and made a part hereof.

ARTICLE III - DURATION

This corporation shall have a perpetual existence, unless dissolved according to law.

ARTICLE IV - PURPOSES

The purposes for which the corporation is organized are:

A. 
