Articles of Incorporation

of

Central Commerce Park Association, Inc.

(A Not For Profit Corporation under Chapter 617, Florida Statutes)

The undersigned acting as incorporator of a not for profit corporation under the Florida Not for Profit Corporation Act, adopts the following articles of incorporation for the corporation.

Article I - Name

The name of the corporation shall be Central Commerce Park Association, Inc.

Article II - Principal Office

The principal street address is for the corporation is 1681 Success Drive, Cantonment, Florida 32533.

Article III - Purpose

The corporation is organized exclusively: to enforce the Declaration of Covenants, Conditions and Restriction of Central Commerce Park ("Declaration", which Declaration is recorded in Book 5517, Page 1390 of the Official Records of Escambia County, Florida); to exercise the powers recited in the Declaration; and to provide administration, maintenance, and architectural control over the real property that is described in the Declaration ("Subdivision") and is further described as:

Central Commerce Park, Phase 1, as recorded in Plat Book 17, Pages 100, 100A, and 100B of the public records of Escambia County, Florida.

The corporation may exercise any powers enumerated in the Declaration, the corporation's bylaws, and those bestowed by applicable law.

Article IV - Manner of Election

The manner in which the directors and officers are elected or appointed shall be as stated in the corporation's bylaws.

Article V – Membership and Voting

Every person or entity that is a record owner of a lot in the Subdivision, whether individually or together with others, shall be a member of the corporation. The manner in which members vote shall be as stated in the corporation's bylaws.

Article VI – Initial Directors

The following persons shall be the initial directors of the corporation:

Article VII - Initial Registered Agent and Street Address

Article VIII - Incorporator


