Articles of Incorporation of

Take20ForLife, Inc.

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under the section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The business activity for said organization is as follows: Aims to prevent suicide by providing education and resources aimed at focusing on: Taking 20 minutes for Life. Taking an additional 20 minutes before going through with the decision to take one's life may result in a life saved. The 20 minutes may look life: A phone call to a friend or family member, a walk, journaling, meditation, calling the suicide hot-line, or, going to the Take20Fort life website. Funds will be aimed at lobbying for changes in mental health care services, availability of counseling and/or psychological treatment services for all income levels, education to school nurses in schools on what to look for in students who my be at risk, marketing, guest speakers for middle college level, researching how the pandemic has affected mental health and maybe increased the risk of suicide in the population as a whole. Developing and spreading resources, creating a phone line that can feed into the suicide hot line is a goal for this endeavor.

No part of the net earnings of this organization shall inure to the benefit of, or be distributable to, its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set fortherein. No substantial part of the activities of this corporation shall be the carrying on propaganda, or otherwise attempting to influence legislation, and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), and political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of this document, the corporation shall not carry or any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c) (2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Upon the dissolution of this corporation, assets remaining shall be distributed for one or more exempt purposes within the meaning of Section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed by a Court of Competent Jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes
