The undersigned incorporator, for the purpose of forming a corporation not for profit under Chapter 617 of the Florida Statutes, does hereby adopt the following Articles of Incorporation:

ARTICLE I

NAME

The name of this Corporation is ALAN B. BOOKMAN SERVICE IN LEADERSHIP, INC. (the "Corporation"). The Corporation is organized under the Florida Not for Profit Corporation Act.

ARTICLE II

INITIAL PRINCIPAL OFFICE AND MAILING ADDRESS

The initial principal office and mailing address of this Corporation is 30 South Spring Street, Pensacola, FL 32502.

ARTICLE III

PURPOSES

This Corporation is hereby organized as a not for profit organization and is to be operated for the founding and direction of the Alan B. Bookman Memorial Fund which is to be used exclusively for charitable purposes including the protection of legal rights of those most vulnerable in our community and furthering access to justice.
