ARTICLES OF INCORPORATION

In compliance with Chapter 617, F.S. (Not for Profit)

<u>ARTICLE</u> I NAME

The name of the corporation shall be Gainesville High School NJRTOC. Inc.

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE

This organization exists to provide financial assistance and moral support to the Gainesville High School Naval Junior Reserve Office Training (NJROTC) program, its directors, and to the school authorities, in the pursuance of their programs and objectives, within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law. This support will be accomplished by recruiting volunteers, raising funds, and hosting charitable events. Upon dissolution of the corporation, its assets shall be disposed of exclusively for the purposes of the corporation or distributed to such organizations organized and operated exclusively for charitable purposes which shall, at the time, qualify as exempt organizations under section 501(c)(3), or shall be distributed to the federal government, or to a state or local government, for a public purpose.
