The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby form a non profit Corporation under Chapter 617 of the Florida Statutes.

#### **ARTICLE 1 - NAME**

The name of the Corporation is **CREATING HOMES FOR HUMANITY, INC.**, (hereinafter "Corporation).

# ARTICLE 2 - PURPOSE OF CORPORATION
