ARTICLES OF INCORPORATION

OF

AMTATEMP, INC.

In compliance with Chapter 617, F.S. (Not for Profit)

- 1. Name. The name of the corporation shall be AMTATEMP. Inc.
- 2. <u>Principal Office</u>. The street address of the principal office of the corporation is 13435 Danielson Street, Poway, California 92064. The mailing address, if different, is P.O. Box 14918, Tallahassee, Florida 32317.
- 3. <u>Purposes</u>. This corporation is organized, and shall be administered and operated, primarily to receive, administer, and expend funds to promote social welfare, and for civic purposes, both within the meaning of Section 501(c)(4) of the Internal Revenue Code of 1986, and in particular:
- particular:

 (a) To promote the use of desalination, waste water reclamation, and other water sciences, and to exchange and spread information concerning the state of the art of desalination, waste water reclamation, and other water sciences to enhance the quality of the environment of city life;
 - (b) To assist other organizations in the accomplishing the same purpose; and
- (c) To engage in any and all lawful activities incidental to the foregoing purposes except as restricted herein.

To accomplish the foregoing purposes, and for no other purpose or purposes, this corporation shall also have the powers granted to nonprofit corporations by the Florida Not for Profit Corporation Act, and may do all other acts necessary or expedient for the administration of the affairs and attainment of the purposes of this corporation; provided, however, that this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the primary purposes of this corporation.

- 4. <u>Directors</u>. The number of Directors and the manner of their election shall be fixed by the bylaws.
- 5. <u>Registered agent</u>. The registered agent's name and street address in the State of Florida is Kimberly A. Shugar, 1545 Spruce Avenue, Tallahassee, Florida 32303.

- 6. <u>Members</u>. The corporation shall have members, whose qualifications, rights, and obligations shall be as set forth in the bylaws.
- 7. Restrictions. (a) The assets of the corporation shall be irrevocably dedicated to charitable and public purposes. No part of the net income of the corporation shall inure to the benefit of or be distributable to its directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services actually rendered and to make payments and distributions in furtherance of the purposes and objects set forth in Article 3.
- (b) Notwithstanding any other provision of these Articles, the corporation shall not conduct or carry on any activities not permitted to be conducted or carried on by an organization exempt from tax under Section 501(c)(4) of the Internal Revenue Code of 1986.
- 8. <u>Liability</u>. The private property of the incorporator, directors, and officers shall not be subject to the payment of corporate debts to any extent whatever.
- 9. <u>Dissolution</u>. Upon the dissolution of the corporation or the winding upof its affairs, its assets shall be distributed exclusively for its purposes or to organizations which are then the from federal tax under Section 501(c)(3) or Section 501(c)(4) of the Internal Revenue Code of 986.
