

American Friends of Bikurim, Inc. – Articles of Incorporation Article III Purpose (cont'd):

No part of its earnings may insure to any private shareholder or individual. In addition, it may not attempt to influence legislation as a substantial part of its activities and it may not participate in any campaign activity for or against political candidates.

Upon the dissolution of this organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, such as charitable, religious, educational and/or scientific purposes, or shall be distributed to the federal government, or to a state or local government for public purpose.
