#### ATTACHMENT A.

# FALLCHASE AT PATHSTONE OWNERS ASSOCIATION, INC. (A CORPORATION NOT-FOR-PROFIT)

The Articles of Incorporation of Fallchase at Pathstone Owners Association, Inc. is hereby amended as follows: (double underlines indicating additions and strike throughs indicating deletions):

#### ARTICLE IV PURPOSE(S)

3. The Association shall To levy and collect adequate assessments against Members of the Association for the costs of maintenance and operation of the Stormwater Management System. The assessments shall be used for the maintenance and repair of the Stormwater Management System and mitigation or preservation areas, including but not limited to work within retention areas, drainage structures and drainage easements.

### ARTICLE V GENERAL POWERS

- 5. To levy Assessments and other charges on Lots, collect such Assessments and other charges from Lot Owner Members, and to use the proceeds thereof in the exercise of its powers and duties including the maintenance and repair of the Stormwater Management Systems and mitigation or preservation areas, including not limited to work within retention areas, drainage structures and drainage easements.
- 13. The Association To shall operate, and maintain and manage the Stormwater Management System, including all inlets, ditches, swales, culverts, water control structures, retention and detention areas, ponds, lakes, floodplains compensation areas, wetlands and any associated buffers and wetland mitigation areas, preserve areas and conservation easements, as applicable and required by the Permit, and to contract for services to provide for such operation and maintenance, with the power to accept future phases into the Association that will utilize the Stormwater Management System(s), as applicable and required by the Permit in a manner consistent with the requirements of NWFWMD Permit No. CON-033-286367-L and applicable NWFWMD rules, and shall assist in the enforcement of the restrictions and covenants contained herein.

#### ARTICLE XI CORPORATE EXISTENCE

Existence of the Association shall commence with the filing of these Articles of Incorporation with the Secretary of State, Tallahassee, Florida. The Association shall exist in perpetuity. The Association-shall-have perpetual existence. If the Association is dissolved, the control or right of access to the property containing the Surface Water Management System Facilities and other dedicated-property and related infrastructure shall be transferred to, accepted and maintained by an entity in accordance with Rule 62-330.310. Florida Administrative Code, and the Environmental Resource Permit Applicant's Handbook Volume 1. Section 12.3, as such may be amended from time to time, and be approved by the WMD prior to such termination, dissolution, or liquidation.

#### ARTICLE XVI DISSOLUTION

Except as specifically amended hereby, the Articles of Incorporation shall remain in full force and effect as originally executed and filed.
