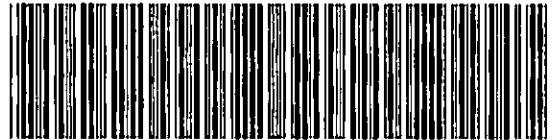

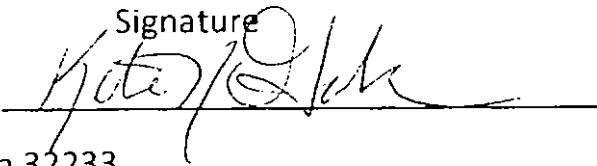
VI. Officers

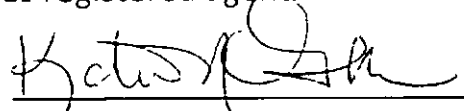

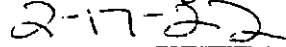
