Articles of Incorporation of

Each1 Reach1 Inc.

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under the section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The business activity for said organization is as follows: To win souls for Christ by helping the unfortunate. To build up an individual when one's spirit has been torn down. To restore life through Christ when one's spirted has been broken. To help when someone who has no one to reach out to including battered women, the homeless and children trying to find their way in a broken world. To help by providing clothing and shelter and food to anyone in need. It's also to help children with homework to help keep them off the streets. To replenish the broken hearted through the gospel of Christ. To reach people outside of the church in the community.

No part of the net earnings of this organization shall inure to the benefit of, or be distributable to, its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forthherein. No substantial part of the activities of this corporation shall be the carrying on officers. propaganda, or otherwise attempting to influence legislation, and this corporation shall noto participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of this document, the corporation shall not carry approximately other activities not permitted to be carried on (a) by a corporation exempt from federal? income tax under section 501(c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c) (2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
